

TERMS AND CONDITIONS / PUBLIC OFFER AGREEMENT

1. Terms

1.1. **Contractor** — SmsBuyz service (hereinafter referred to as "SmsBuyz"), which provides a platform for receiving SMS messages for verification purposes via virtual phone numbers.

1.2. **Customer** — a natural or legal person who accepted this Offer by means of registration on the Website.

1.3. **Website** — the Internet resource located at <https://smsbuyz.com>.

1.4. **Service** — provision of a temporary virtual phone number for receiving a single or multiple SMS messages from a specific service (application).

1.5. **Activation** — the process of selecting a service, purchasing a number, and receiving SMS verification.

1.6. **Electronic Virtual Account** — a virtual balance on the Customer's account on the Website, intended for payment for Services.

1.7. **API** — an application programming interface provided by SmsBuyz for automated interaction with the Service.

2. Subject of the Agreement

2.1. The Contractor undertakes to provide the Customer with Services specified on the Website, and the Customer undertakes to pay for the Services.

2.2. The list of available Services, their cost, and conditions are published on the Website and may be changed by the Contractor unilaterally.

3. Terms of Service

3.1. The Service is provided on the terms of a public offer and is deemed accepted (accession to the agreement) from the moment of registration on the Website.

3.2. The Customer uses the Services at their own risk. The Contractor does not guarantee that the Services will meet the Customer's requirements or expectations in all cases.

3.3. The Contractor reserves the right to refuse to provide the Service without explaining the reasons.

4. Payment Procedure

4.1. Payment for the Services is made by replenishing the Electronic Virtual Account using the payment methods available on the Website.

4.2. The cost of the Service is debited from the Electronic Virtual Account at the time of order placement.

4.3. If the SMS was not received within the allotted time and the Customer cancels the activation, the funds are returned to the Electronic Virtual Account automatically.

5. Customer Responsibilities

5.1. The Customer agrees:

- not to use the Services for illegal purposes;
- not to attempt to hack, modify, or disrupt the operation of the Website;
- to comply with the rules posted on the Website.

5.2. The Customer is solely responsible for the legality of using the Services in their jurisdiction.

6. Contractor Responsibilities

6.1. The Contractor undertakes to make reasonable efforts to ensure the availability and quality of the Services.

6.2. The Contractor is not responsible for interruptions in the operation of the Website caused by force majeure, actions of third parties, or technical failures.

7. Limitation of Liability

7.1. The Contractor's total liability under this Agreement shall not exceed the amount of funds on the Customer's Electronic Virtual Account.

7.2. The Contractor is not responsible for any indirect, incidental, or consequential damages.

8. Final Provisions

8.2. All disputes arising in connection with this Agreement shall be resolved through negotiations. If an agreement is not reached, the dispute shall be referred to the competent court in accordance with applicable law.
